THIS PERMIT IS HEREBY GRANTED SUBJECT TO THE ABOVE APPLICANT'S STRICT ADHERENCE TO THE FOLLOWING CONDITIONS:

- No shooting shall be made without prior approval from the Association. The duration of this permit is valid only for the period as specified in letter G above unless otherwise extended by Ayala Alabang Village Association. The applicant will undertake the restoration of the area used to its original condition at his / her own expense.
- Activities other than those mentioned in letter E above will not be undertaken.
- Any and all necessary permits/licenses that need to be secured from any government agency is the responsibility of the applicant.
- Applicant shall be solely responsible for any damages which may result to any third party in connection with the use of such area.
- A **CASH BOND**, depending on the type of shoot (*please refer to the reverse side for the classification & corresponding amount*) is required. Upon completion of the shooting, the applicant must secure clearance from the Location Owner / Resident, Security Department and AAVA Administration prior to the release of Cash Bond (the clearance portion is provided below this permit). The bond can be refunded 2 weeks after the required clearance have been duly submitted at the Association Office.
- The applicant must provide at least One (1) **portalet** during the time of the shooting.
- Written permit from the owner/resident should be submitted if shooting will be done inside his/her property.
- No double parking along the street to avoid traffic congestions.
- Only silent-type generators shall be allowed to be used during the time of the shoot.
- Should there be any complaints from nearby neighbors due to unnecessary nuisance created during the shooting, the shooting shall be stopped immediately by our Security.
- Shooting is allowed only from 6:00 AM to 8:00 PM. Any extension should be cleared and approved first by AAVA as well as the affected neighbors provided that shooting shall not extend beyond 12:00 midnight.
- Any violation of the above condition shall force the Association to impose forfeiture of the Cash Bond.
- The Security Department will deploy its representative to check the conduct of the shooting if the applicant is conforming to the above conditions.
- Ayala Alabang Village Association, its affiliates & employees, shall be free from any liability, including but not limited to loss, theft, damage to items, etc. as a result of this activity.

As per Board Resolution No. B2019-11-01, types of shoot inside the Village shall be categorized as follows, with the corresponding fees & bonds to take effect November 1, 2019, to wit:

Type of Shoot	Purpose	Fee	Bond
Photo	Commercial	P 20,000.00 per shooting day	P 15,000.00
Photo	News/Magazine Feature	P 5,000.00 per shooting day	P 5,000.00
TV	Local production/Telenovela	P 25,000.00 per shooting day	P 15,000.00
TV	News Feature/Local Show (<i>No OB Van</i>)	P 5,000.00 per engagement but should not exceed 6 hours	P 5,000.00
TV	Live Coverage (<i>With additional charge if with OB Van</i>)	P 5,000.00 per engagement but should not exceed 6 hours	P 5,000.00
Film/Video	Commercial	P 25,000.00 per shooting day	P 15,000.00
Film/Video	Full length movie production	P 25,000.00 per shooting day	P 15,000.00

Additional charges will also have to be paid for the following:

- 1) Entrance fee for Generator set (should be silent type & with trailer) – **P 2,000.00 per unit per engagement**
- 2) Entrance fee for OB Van – **P 2,000.00 per unit per engagement**
- 3) Payment of two (2) Security Personnel – **P 1,875.00 per Guard fixed rate; additional P 160.00 per hour per Guard if shooting will go beyond 12 hours**
- 4) Extension beyond 8:00 p.m. – **P 2,000.00 per hour**
**Extension shall still be subject to clearance & approval from AAVA & the affected neighbors; if approved, extension of shoot is up to 12:00 midnight only.*

Permit will be granted to school projects requiring film and photo shoot free of charge provided that the following are complied with:

- 1) Letter using the School's official letterhead and signed by the School Dean stating the required project;
- 2) No OB vans and /or generators, only handycam/camcorders will be allowed; and,
- 3) Students are residents of Ayala Alabang Village.

For location hunting/scouting, the following shall still be observed:

- 1) A permit should be secured first from the Association office. The following should also be complied with:
 - a) Letter from the company stating the purpose of the shooting.
 - b) Only digital camera/handycam can be used.
 - c) Maximum of 5 persons to scout the area.
- 2) The permit shall be exclusively used for its intended purpose and location (i.e., parks &/or roads) only and should not be used for house-to-house scouting. House scouting will be allowed only if with the prior approval of the concerned resident.
- 3) A security personnel shall escort the team and once finished, the Security personnel shall forward the permit to Administration Department for record purposes.
