1. Certificate of Registration & Official Receipt (Vehicle must be in the resident’s and/or lessee’s name) – Photocopy
2. Sales Invoice if newly acquired - Photocopy
3. If company-owned vehicle, a certification from the company authorizing the said applicant to use the vehicle
4. Updated Lease Contract (for Lessee)
5. Vehicle must be present on site for sticker installation.
6. RESIDENT STICKER is not transferrable.
7. Proof of relationship (Birth Certificate, Marriage Contract adaption documents, etc.) to ascertain relationship of the applicant with the homeowner/lessee.
8. Car rental agreement if rented.
